NURSE AIDE

Certificate Course

This program provides essential core knowledge and practical skills that nurse aides need to care for patients in medical and/or health-care facilities. Students acquire an understanding of common perception from medical terminology and abbreviations to legal and regulatory aspects of practice as a certified nurse aide. This is a 120-hour program which includes 40-hour clinical rotations (externship), through which students can acquire hands-on experience.

About Nurse Aid Program

- Total of 120 hours A Brief Period of On-the-job Training for Job Seekers
 - To learn about specific employer policies and procedures

 - After completing this program, students can take a competency exam and are allowed to use state-specific title, which is a Certified Nursing Assistant (CNA)

Nurse Aid Prospects

- Demand for nursing assistants may be constrained by the fact that
 many nursing homes rely on government funding. Cuts to programs,
 such as Medicare and Medicaid, may affect patients' ability to pay
 for nursing home care. However, patient preferences and shifts in
 federal and state funding are increasing the demand for home and
 community-based long-term care, which should lead to increased
 opportunities for nursing assistants working in home health and
 community rehabilitation services.
- Job prospects for nursing assistants who have completed a state-approved education program and passed their state's competency exam should be good, particularly in home health care services and community-based care settings.
- Employment of nursing assistants is projected to grow 21 percent from 2012 to 2022, faster than the average for all occupations.
